

**SEVERANCE SOUTH METROPOLITAN DISTRICT NOS. 1-4**

**CONSOLIDATED RESOLUTION ADOPTING TECHNOLOGY ACCESSIBILITY STATEMENT**

WHEREAS, the Severance South Metropolitan District Nos. 1-4 (the “Districts”) are quasi-municipal corporations and political subdivisions of the State of Colorado located in the County of Weld, Colorado; and

WHEREAS, as governmental entities and political subdivisions of the State of Colorado, the Districts are subject to and required by Section 24-34-802(c), C.R.S., to comply with the Rules Establishing Technology Accessibility Standards (the “Rules”) established by the state Office of Information Technology (“OIT”) on or before July 1, 2024; and

WHEREAS, the Rules apply to all information and communication technology (ICT) that is in active use by the Districts on or after July 1, 2024 and any ICT that is newly created, developed, acquired or purchased by the Districts; and

WHEREAS, the Rules require the adoption of a technology accessibility statement which includes the Districts’ commitment to a timely response to any reports of inaccessible ICT or requests for reasonable accommodation or modification, and notice to individuals with disabilities of how to request reasonable accommodation or modification, or to report inaccessible ICT.

NOW THEREFORE, be it resolved by the Boards of Directors of the Severance South Metropolitan District Nos. 1-4 that the “Technology Accessibility Statement” attached as Exhibit A to this resolution, is approved.
